CLERY ACT INFORMATION

The Clery Act is the result of a young College Student by the name of Jeanne Clery found murdered inside her University dorm room. This tragedy was a result of lack of reporting and under reporting crimes that happened at the University that Clery attended by campus police and security personnel. As a result Jeanne Clery's parents, Connie and Howard Clery, committed themselves to create enduring change on University sites mandating the published reports of crimes. In 1990, Congress approved the Crime Awareness and Campus Security Act, which was later renamed in Jeanne's memory, the Jeanne Clery Act, which took effect in 1991.

Lincoln Memorial University Law Enforcement Officers have full powers of arrest under the State of Tennessee's general statues they are sworn to uphold. The Law Enforcement Jurisdiction is exclusive to property owned and controlled by Lincoln Memorial University. All LMU sworn law enforcement officers are continuously trained throughout the year with mandated in-service training required by the Tennessee Peace Officers Standards and Training Commission. They are additionally trained above the state mandated level of training as needs arise as incidents continue to happen around the world.

Lincoln Memorial University's Armed and Unarmed Security Officers have the authority to enforce school rules and have full arrest powers. The security officers are required to attend annual mandated training which meets the Tennessee and Virginia certification requirements. Each security officer receives additional training above the state mandated level that is exclusive to the issues that concern Lincoln Memorial University.

The Clery Act requires all Universities to:

- Have in place primary and ongoing prevention and awareness programs and campaigns for students and employees concerning:
- o Geography
- Crime Statistics
- Daily Crime Log
- Emergency Notification
- Annual Security Report
- Missing Students
- Fire Safety Disclosure/statistics
- Fire Log/statistics
- Annual Fire Report
- Disclose the previous mentioned topics in our policies and procedures in the annual security report.
- Provide the primary education programs as part of the orientation process for new students and employees whenever they start.
- Ongoing campaigns should be visible throughout the year.

The Jeanne Clery Act requires that colleges and universities:

- Keep a public crime log publish an annual security report that includes crime statistics and security policies.
- The Annual Crime and Fire Report may be viewed online.
- Provide timely warnings to students and campus employees about a crime posing an immediate or ongoing threat to students and campus employees.
- Ensure certain basic rights for victims of sexual assault, dating violence, domestic violence, and stalking.
- Annual training for all University staff

- o New student and returning student awareness training
- On-going seminar training and access to the most updated information.

Crime Prevention Services

A highly-trained **Crime Prevention Officer** is on staff to provide safety advice, instruction and support to the campus community. The Crime Prevention Officer is also responsible for all campus crime prevention programs.

Emergency Call Boxes: There are call boxes located throughout the campus. The emergency call boxes are identified by distinctive RED signs. Each emergency call box has a call button. Press the CALL button for emergency assistance. Officers will respond to you immediately.

Anonymous Tip Line: The Anonymous Tip Line program provides yet another option to anonymously provide information about a crime. Simply call 423-869-7159 and leave your anonymous tip.
