Prescription Drug Information

VeracityRx

LMU is partnering with Veracity to manage your pharmacy benefits. If you are enrolled in the BCBS medical plan, you will receive a prescription ID card in the mail from VeracityRx that you will present whenever you go to the pharmacy to fill a prescription. There are specific ways that the Pharmacy program partners with you to save you money.

Select vs. Non-Select Pharmacies

When you fill your prescriptions at Select Pharmacies your costs are lower, and 90-day refills are available. Select pharmacies include grocery stores such as Publix and Food City, Costco, and locally owned neighborhood pharmacies such as Fairyland Pharmacy, Flintstone Pharmacy, Moore & King, Rapid Rx and Signal Mountain Pharmacy. Effective February 1, 2024, Walmart and Sam's Club will be Select pharmacies. Non-Select pharmacies have higher co-pays and do not authorize 90-day fills. The following pharmacies are considered Non-Select: Target, CVS, Walgreens, and Rite-Aid. To locate a Select pharmacy near you, call VeracityRx at (888) 388-8228.

90-day Fills

You can choose to get a 90-day fill using your local Select pharmacy. This benefit is not covered at Non-Select pharmacies listed above.

High Cost Specialty Medications

Specialty medications are **EXCLUDED** from the plan. Assistance in obtaining your specialty medications is available through VeracityRx Specialty Pharmacy Services. Specialty medications are often prescribed to treat complex and rare diseases, and many of them cost \$2,000 or much more per month. Many of the drugs advertised on television are specialty medications. If you or a covered dependent are prescribed a specialty drug, the VeracityRx pharmacy team will contact you and ask you to enroll at **www.veracity-rx.com**. In many cases, they can get the medication at **no cost to you and to LMU**. After you enroll, they will immediately follow up and walk you through the next steps. You will **NOT** go without your medication.

ACTION REQUIRED FOR SPECIALTY MEDICATIONS

To participate in this program, you will be required to submit certain documentation. These documents typically include:

- Signed copy of your most recent federal tax return
- Front and back copy of your medical insurance card
- Limited Power of Attorney only for purposes of seeking assistance with specialty medications.

To participate in this program, you will be required to submit certain documentation. These documents typically include a signed copy of your most recent federal tax return and the front and back copy of your medical insurance card. If you choose not to participate in this program, you will be responsible for the full cost of the specialty medication. This cost will not apply to your deductible or out of pocket.

Getting started is simple. If you or a covered dependent are currently taking a specialty medication, go ahead and enroll now at www.veracity-rx.com. They will guide you through each step of this simple process.

Personal Importation Medications (International)

VeracityRx's pharmacy team can help you fill specific drugs at no cost from their pharmacy partner in Canada. Name-brand medications for diabetes, HIV, COPD, depression and cardiovascular medications like Trulicity, Farxiga, Descovy, Jardiance and many more can be accessed through this program. Please review the list of commonly prescribed international medications, and if your medication is on that list, please enroll at www.veracity-rx.com as soon as possible. If you choose not to participate in the Personal Importation Medications Program, you will be responsible for 50% of the
