

## Doctor of Osteopathic Medicine (DO)

The National Board of Osteopathic Medical Examiners (NBOME) is an independent, nongovernmental, not-for-profit organization whose mission is to protect the public by providing the means to assess competencies for osteopathic medicine and related health care professions. The NBOME develops and administers the COMLEX-USA (Comprehensive Osteopathic Medical Licensing Examination of the United States) exam. These consist of three (3) levels. LMU-DCOM students are required to take and pass COMLEX Level 1 and Level 2 CE exams prior to graduation. Passing COMLEX Level 3 is required after graduation to obtain licensure. The COMLEX-USA exams are accepted for medical licensure in all 50 of the United States and all U.S. territories. Visit [NBOME.org](http://NBOME.org) for more information.
