Direct any questions regarding eligibility to take the licensing examination to the board of nursing in the state in which the student wishes to be registered.

Graduates of the Master of Science in Nursing (MSN) Family Nurse Practitioner (FNP) concentration will meet the eligibility requirements for the FNP certification examinations offered by the American Nurses Credentialing Center (ANCC) or the American Academy of Nurse Practitioners (AANP).

Graduates of the MSN Family Psychiatric Mental Health Nurse Practitioner (FPMHNP) concentration will meet the eligibility criteria for the American Nurses Credentialing Center (ANCC) FPMHNP certification examination.

Graduates of the Post Bachelor's DNP Nurse Anesthesia (NA) concentration will have met the eligibility criteria for the National Board for Certification and Recertification of Nurse Anesthetists (NBCRNA) national certification examination.

Upon successful completion of the MSN Nursing Administration Concentration, graduates are eligible for certification examinations from the American Nurses Credentialing Center (ANCC), or the American Organization of Nursing Leadership (AONL) provided they have met the practice requirement for the examinations.
