## LMU Students Receive Ledford Scholar Awards From Appalachian College Association

- Evan Collett for his project, “Piroplasms in the Genera Babesia, Theileria, and Cytauxzoon from Ixodid ticks in the Cumberland Gap Region”
- Ian Cook for his project, “Can Eastern Hellbender (*Cryptobranchus alleghaniensis*) populations be detected in the Susquehanna River Watershed of New York State using eDNA survey methods?”

Dr. Martin Sellers, Dean of the Paul V. Hamilton School of Arts, Humanities and Social Sciences presented at the ASPA Virtual Conference, Potential Directions for the Future of Technology through a Social Equity Lens. The conference was held on April 10, 2021 and the title of his presentation was, "Online MPA Program: When, Why and How to Transition from Seated to Online".

*Should a seated MPA program be transitioned to an online or blended online? This was the issue that was discussed and debated at Lincoln Memorial University for over a year. Trustees, administrators, faculty, students and staff had a hand in the decision making process. The compelling components were tuition, enrollment, flexibility and student need. The elements weighing against a transition were teaching pedagogy, participation of local and state speakers, internships, and a desire to have students connect outside the classroom. The pathway to transitioning to an online program is a tangled one, but can be straightened out by sticking to a few well thought out rules.*

## Honors Scholars Program

In February, five Honors Scholars, Emily Roark, Sarah Hopkins, Jarvis Pennington, Kurtis Orrson and Emma Cummings, presented at the Tennessee Collegiate Honors Council Conference, along with honors students from 11 other institutions in the state. HSP students competed with other colleges and universities in a trivia contest midday, the winning school received bragging rights! Dr. Sandra Weems, Assistant Professor of English, represented the LMU HSP by hosting and moderating one of the sessions at the virtual conference.

In March, Dr. Weems and two students presented papers at an all-LMU panel at the 10th Annual International Health Humanities Consortium. The virtual conference was hosted by Penn State University and attended by an interdisciplinary group of 250 attendees, including physicians and humanities scholars from a wide range of specialties and disciplines.

The conference theme was *Crisis and Community: The Role of Health Humanities*. Dr. Weems said when the call for proposals came out last fall, she realized that she and two of her students had overlapping interests about ways the global pandemic had affected many people's relationship to food and, as a result, their physical and mental health. So, we proposed and were accepted to present a paper panel that examined these issues in different ways.

Katherine DeMars, a medical student at DCOM, drew on her experiences in her third-year rotations and research in social determinants of health to present "Hungry for Change: The complex relationship between nutrition, socioeconomic status, and health outcomes."

Jennifer Gambrel, an English undergraduate, surveyed the new and growing sub-field of medicine and psychology called "culinary therapy" and presented her research in a paper titled "Culinary Therapy Cooks Up Benefits."

Dr. Weems presented a paper based on pedagogy and student response in my ENGL 350 class, Narrative, Healing, and the Body, called "Lessons Online: Teaching Jessica Fechter's *Stir* During Lockdown in Appalachia."
