To be eligible for a Federal Direct Student Loan, you must complete a Free Application for Federal Student Aid (FAFSA), maintain Satisfactory Academic Progress (SAP), and be enrolled at least half-time. Yearly loan amounts will be divided into equal disbursements. **Please note that loan origination fees charged by the U.S. Department of Education will be deducted from the amount you borrow.**
