Yearly loan amounts will be divided into equal disbursements. **Please note that loan origination fees charged by the U.S. Department of Education will be deducted from the amount you borrow.**

If I drop classes or stop attending school, my loan could be prorated or canceled, and I may owe money to LMU. The amount I request may be reduced or rejected based on annual loan limits, federal regulations, or LMU policy. I must repay my loans even if I don't complete my education or if I am unable to get a job after I complete my program.
